## Terms and Conditions

1. General: Dealer Assist Now ("daN") and Dealership ("Dealer") specified above hereby enter into a relationship whereby daN will enter the Dealer's advertisements ("Comments/Sellers notes") on the website specified by Dealer. Dealer Assist Now Service Agreement ("Agreement") sets out the Standard Terms and Conditions of the relationship and will be applicable to each advertising placement. Other terms applying to specific advertising placements are specified below. daN may update these Standard Terms and Conditions from time to time upon notice to the Dealer Terms and Conditions will apply to any subsequent Sales Orders.
2. Payment Terms and Conditions: Dealer will pay daN specified fees stated at sign up. However, Dealer pricing may change based upon periodic inventory evaluations. If Dealer objects to such change, Dealer may cancel daN services as stated in #4. Dealer will pay any federal, state, or local taxes imposed on the display of the Advertisements.
3. Authorization Agreement: I authorize Dealer Assist Now, LLC to charge my monthly subscription/maintenance fee for comments, directly to my credit card IF indicated in Agreement. I further authorize daN to make refunds, if any, directly to my credit card. I understand this is a recurring authorization and will remain in effect for future agreement service terms until I provide daN with written cancellation as stated in #4. I also understand that daN and/or my financial institution can cancel my enrollment in this program at any time. Failure to pay monthly account charges will cease maintenance of ALL sites effective at 15 days delinquent, at daN discretion.
4. Terms and Renewal: "Service Term" shall be for a one month period, beginning on the first day of the month and ending on the last day of the month. Agreement will commence upon date of execution, by daN and Dealer; if necessary, account billing will be prorated from date of execution to correlate with "Service Term". Each Sales Order will remain in effect for a "Service Term", then automatically renew for an additional "Service Term", unless Dealer gives daN written notice of its intent not to renew at least 30 days prior to the next renewed "Service Term", as applicable.
5. Completeness: Dealer acknowledges that daN has made no guarantees with respect to usage statistics or levels of impressions that will be delivered on any site.
6. Advertising Materials: Dealer will, at its expense, provide all photo's for "Comments/Sellers Notes" in accordance with daN policies by site placement for writer review.
7. Access to Marketing Sites: daN may access Dealer's new, certified, and used car inventory with Dealer provided user name(s) and password(s). If Dealer fails to pay for the marketing services and service is interrupted, daN cannot override any suspended account and will not be responsible for any lost "Comments/Sellers Notes" which may result.
8. Change of DMS that results in Loss of Comments - Dealer will be responsible for securing copies of Pictures, Pricing, as well as Comments. This shall be the sole responsibility of the dealer - Failure to secure comments during a DMS Change will result in an additional re-write or copy over fee charged to the dealer.
